Chair of Real Estate, Logistics and Entrepreneurship

The Chair of Real Estate, Logistics and Entrepreneurship has three directions of scientific activities: 1) real estate market and real estate valuation methodology development; 2) entrepreneurship and SME development and 3) improvement logistic network.

In 2011 the research in the field of real estate was focused to a new Estonian real estate quality rating system, which is designated for valuation of real estate. The research seeked to identify 1) whether and to what extent real estate valuers attach importance to real estate quality assessment, 2) how does the valuers' new quality rating system meet their needs, and 3) what is the hierarchy of the indicators preferred by them. The results of the survey confirm that real estate quality assessment based on the methods worked out is relevant for real estate valuation and taking account of the hierarchy of the factors influencing the quality enables to present a more accurate assessment of the real estate quality.

Research on entrepreneurial career intentions and motivations of students in higher education in different countries (in Europe, US, Asia and Africa) have shown that most students prefer an organisational employment directly after studies, and the intention to found an own company increases considerably five years after completion of studies. The most important motives having a significant effect on students' intention to become a founder are: realise own dream, achieve something, higher income and challenge myself. The study have indicated higher entrepreneurial intentions and attitudes towards entrepreneurship among the respondents from developing countries (incl CEEC) compared to the students in developed countries (e.g. Europe), although the motivators for employment/self-employment were rather similar. The research on the impact of entrepreneurship education courses to students' attitudes and competences (based on the case of creative industries) indicates direct implications for developing the content and process of entrepreneurial learning in universities and how to focus their programmes.

The goal of the project BACN Baltic Air Cargo network is to study the current situation and future perspectives of air cargo sector in the Baltic Sea Region. More specifically: to define air cargo development scenarios for the region considering export, import and transit as well as the role of airports; to compare air cargo service in project countries in order to collect information for specific local development projects; to identify current sector bottlenecks, which could hinder quality service in case of optimistic volume growth scenario; to formulate suggestions for increasing general competitiveness of European air cargo sector in international dimension.

Over the course of 2011, we've formulated and carried out a joint approach of research in air cargo sector - expert interviews. In Estonia, 12 interviews with representatives of 10 organisations were carried out giving insight into local air cargo sector as well as identifying shortcomings. Furthermore, we formulated a regional profile of Estonian air cargo sector and done comparison with other regional profiles in the project. The information collected so far will lead to analysis over all the project topics in 2012 and will then focus on selected most relevant issues for detailed study.

Centre for Business Research and Development

The research of the Centre is based on international research projects (e.g. Baltic Sea Region Programme; Central Baltic Interreg IVA Programme; GUESS survey). The main subtopics in the research area of entrepreneurship and SME development are connected with entrepreneurial career intentions of students and evaluation of the impact of entrepreneurship education, exploration of support needs of young entrepreneurs in creative industries, the usage and value perception of e-government services among SMEs, research on logistic innovations and internationalisation of businesses.

Research on entrepreneurial career intentions and motivations of students in higher education worldwide (26 countries from Europe, US, Asia and Africa) have shown the important role of universities to facilitate students intentions and motivation to get engaged as entrepreneurs in the future. The study about the exploration of support needs of young entrepreneurs in creative industries in their entrepreneurial activities in Estonia, Finland, Latvia and Sweden have produced understanding of background characteristics, motivational factors and role of education in upgrading their competences. As a result, suggestions for an improved model of entrepreneurship education for creative industries were elaborated.

The main interest in assessment and development of e-government services for enterprises in Estonia, Germany, Latvia, Lithuania and Sweden is connected with finding ways to better satisfy the changing needs of enterprises. The study results have supported the elaboration of e-government solutions as instruments to qualify the public sector for the specific needs of SMEs in the rural areas of Baltic Sea Region.

Research on logistic innovations is important in increasing globalization of industry and trade which is evermore being shaped by global dislocated structures of procurement, production and distribution results in significant demands set on the performance of logistics systems. Only with the development of innovative logistics solutions it will be possible to build and control internationally oriented supply chains in an efficient way, especially along with multimodal freight transport.

Research on building up availability of SME internationalisation services is aimed to find ways for public business services to facilitate and support the internationalisation of SMEs in Estonia, Latvia, Sweden and Finland and to strengthen the business advisors' know-how and their ability to provide high-quality internationalisation services for activating SME internationalisation. A special attention of research is directed to the understanding of the role of fair trade marketing in internationalisation process of enterprises.

Chair of Labour Environment and Safety

The Chair of Work Environment and Safety has two directions of scientific activities: 1) risk assessment at different workplaces and ergonomics as the mean for sustaining the people longer in the work life. During the year 2011 the risk assessment of indoor air was mainly carried in atrium-type buildings and ergonomic-side investigation were carried out in big supermarkets and of workers working with computers. The main hazards and health complaints were solved and treatment and preventive measures proposed to the employers of different companies. Several scientific pares were written by the doctoral students and the lecturers to the international conferences in 2012: ESREL 2012 in Helsinki: hazards in glazed buildings; workability and work reliability of hospital workers in emergency department; the improvement of working conditions during monotonous work; biosystems engineering conference in Tartu: noise and vibration of lawn maintenance machines; computer workers rehabilitation possibilities; Hazards XXIII in Liverpool: hazards in handling of oil shale oil etc. The doctoral students have also investigated the ageing people possibilities to get work places; electromagnetic fields hazards in work and during leisure time. The modern measuring equipment has enabled to carry out investigation of indoor air quantities as velocity and humidity of the air and CO₂(TESTO 435) and dust (EPAM) content in the air, the investigation of noise at different frequencies; investigation of vibration (SWAN). The results of the international and national projects have given the possibility for the recommendations to the Ministry of Social Affairs and the National Labour Inspectorate in the field of Occupational Health and Safety for improvement of work environment in Estonia.

Chair of Marketing

The chair of marketing has four main directions of the scientific interests:

Consumer Behaviour, including consumer loyalty and customer relationship, ethnocentrism, and cosmopolitanism. Current research topic ended with Oliver Parts' special research for his doctoral thesis in 2011. Also the chair of marketing is one of 37 university- partners in the Consumer Behaviour Research Network, taking part in COnsumer BEhaviouR Erasmus Network (COBEREN). Completed research design for collection of primary data on consumer culture. Data collected. Data analysed and to be published in current year.

Experience Marketing. Studies in the framework of the project are based on theoretical and empirical international and national economic analysis. Different methodological approaches are used and integrated, including empirical studies to use the LCEEI (LEO) experience pyramid to study product and service design in collaboration with researchers of University of Lapland. The project involves studies of two doctoral students with the topics: Experience Marketing: Brands, Challenges and Prospects and Social media marketing and involving consumers in the marketing process through experience design. Leppiman, A. is the official and certificated ekspert in Estonia in this area.

Hidden Champions on CEE. Methodology of the project is based on H.Simon's research. Coordinated by CEEMAN Association, 165 CEE enterprises from 18 countries have been studied. In 2011, hidden champions in Estonia were investigated. Detailed interviews with the CEOs (5 enterprises) and an analysis of financial and economic reports were conducted, completed by a research report.

Transfer of Innovation, Multilateral Projects, Leonardo Da Vinci. Aim of the European project: A: Train the teachers of six partner universities. B: Play marketing simulation tool Emerald Forest with students of TUT in cooperation with teachers from the Netherlands. Results: 90 students from TTU participated in the game.

Chair of Operations Management

The topics of researches has been as follows:

Innovation policy in Estonia.

a) Special attention was paid to *Technology Transfer, incl. Experience Transfer Models and practices in Estonian SME-s*. This topic has direct connection with clusters, technology parks and industrial parks, university and industry cooperation. These topics are investigated in the framework of Leonardo da Vinci Transfer of Innovation Project „Experience Transfer Model“ (project number 2010-1-SE1-LE005-04801). Publications together with project partners in progress.

b) *Acquisitions and risk management in industrial services*. Preliminary results are given in the paper “Risk management in connection with acquisitions in maintenance and testing services” – by M.Saat, S.Björklund and J.Himmelsbach and two doctoral theses (work in progress).

Management Values and Corporate Social Responsibility

a) *Possibilities of using ethical theories for assessment of corporate social responsibility*.

Preliminary results of research will be published by M.Saat and M.Meel in the paper „Using Kantian Ethics for Estimating Corporate Social Responsibility“.

b) *Relationships between corporate sustainability, corporate social responsibility and management values*.

Preliminary results were published by A.Virovere, E.Titov and M.Meel in the paper „Change of Management Values in Estonian Business Life“ in Chinese Business Review and by E.Titov and K.Kuimet in the paper „Post-Recession Values in Estonian Organizations“ (work in progress).

c) Working out „Model of Ethics Auditing Model for Estonian SME-s“ by Merle Rihma together with Mari Meel.

Company productivity factors in manufacturing.

Special attention is paid to *Lean production problems and consequences* (A.Miina is finalising his doctoral theses) and *methodological problems of productivity management* (E.Kalle has 4 publications about the topic this year).

Participation in researches on topics of *energy economics and policy*, concentrating especially to *renewable electricity and subsidising* - M.Saat, K.Kallemets, J.Kleesmaa and H.Kitzmann.

Results of researches are and will be published in papers for scientific journals and books, also in project reports. We are together with project partners from Swedish, British and German Universities making efforts for implementing system for Accreditation of European Production Engineers in EU.?? At the moment there are no concrete results, mainly because application for financing is not approved yet.

Chair of Organisation and Management

The research subject is connected with the field of strategic management of organizations. The main focus of research is concentrated on the concept of organizational dynamic capabilities as the presumptions of creating strategic competitive advantage in the constantly changing ecosystems of companies, especially in the knowledge-intensive and high-technology field. The research focused on the analysis of dependencies and interdependencies between specific aspects of organizational and managerial processes and practices and their manifestations in organizational dynamic capabilities in five main areas:

- 1) project portfolio management
- 2) cooperation and learning processes in organizational networks
- 3) capital companies ultimate owners `basic human values and will
- 4) management practices in Estonian companies
- 5) human resource management model for developing dynamic capabilities

Part of the research in the main areas was done in cooperation with international and national partners. Research of the learning processes in organizational networks was done in the cooperation with the University of Helsinki in the project “ Learning concepts of operations – tools for the management of multicultural production networks“ (financed by TEKES), where our researchers were the part of research team. The research of the management practices in Estonian companies

was done in the cooperation of the University of Tartu and Estonian Business School (financed by Enterprise Estonia).

- 1) doctoral thesis were defended at TTU: Mike Wahl: „ Basic Human Values & Will of Capital Companies` Ultimate Owners and Construction of an Ownership Typology“.
- 2) toolkit (manual) for learning process organization in network companies was developed and will be published in the April 2012 in the project “ Learning concepts of operations – tools for the management of multicultural production networks“
- 3) the analysis of management practices of Estonian companies was prepared and published for Enterprise Estonia. Also 2 scientific articles and 3 conference presentations were published based on the research in the year 2011. In the study of dependencies between the project portfolio management and dynamic capabilities quantitative empirics from 189 Estonian companies was gathered, the analysis of data is in process.
