Majandussotsioloogia õppetool, Chair of Business Sociology

The research group is active in urban and residential interdisciplinary studies. By combining an conceptualisations of the main urban processes of diffusion (e.g. sprawl), densification (e. g. gentrification), dissolution (e. g. gated communities) with spatially reflected socio-economic processes of segregation and privatisation, the research team seeks understanding of the transforming urban residential cultures along the continuities/discontinuities and diversification of ways of residing as a changing dimension of lifestyles. The preferences, dispositions and economic opportunities of individuals and groups in the housing field are considered on the backdrop of the development of residential markets and policies of public provision of housing as they appear interlinked with human conduct in other fields (e.g. work, education, family etc). In theoretical and methodological terms this is to see to further advancement of the theory of practice and the social construction of symbolic meanings and residential identities in a dual relationship between the social and urban experience and architectural practices. The current focuses are on urban public spaces and public interests (e.g. in relation to re-invention of the waterfront area in the city of Tallinn) and ways they are negotiated in multiple user perspectives representing different cultures, capacity and power (local citizens, other consumers, property owners, entrepreneurs and municipality); the on-going studies concern the meaning and practice of modes of urban gentrification, including the conversion of former industrial spaces into multifunctional buildings and areas of wider cultural heritage value. This is partly the concerns of the broad theme of urban renewal, including different institutional and resident/community activities, issues of knowledgeability, capacity and trust. Enhanced individual mobility on the European and global scale has raised new research issues of internationally forming homes, which set the urban residential cultures in a new perspective.

Keskonnaökonomika õppetool, Chair of Environmental Economics

The Chair of Environmental Economics continued clearing up the value of coasts as a valuable socio-economic resource. In 2012, the focus was on two problems: 1) population's demand for coasts in different types of natural condition, and 2) the resource use conflict caused by the utilisation of coastal wind power potential for electricity generation. Research on the conflicts of resource use has also covered the dilemma of closing the recreation area surrounding lake Ülemiste. The population's demand for coasts in different natural conditions was investigated at the example of five main types of coast (silty shore, till shore, clifffed shore, gravel shore, sandy shore) using the Contingent Valuation method and willingness-to-pay technique. The results indicate that there is remarkable financial demand for keeping the natural condition of the coasts, which makes the coasts in the natural condition as a valuable non-market resource socio-economically well competitive with exclusive or competitive use of resources (e.g. real estate development, building of recreational infrastructure).

One of the gravest dangers to the natural conditions of coasts is using them for wind energy production. Construction of the relevant infrastructure would destroy either partly or fully the psycho-social values (e.g. aesthetic value, choice value, future value) and recreational values of the coast. Using the contingent valuation method Estonian population's demand for the coasts without wind turbines was identified. The research results allow concluding that the coasts in the natural conditions as a non-market nature resource is more valuable also economically than the wind energy produced at the price of destroying this resource. Ignoring this fact while erecting wind parks would lead to a remarkable loss of welfare for Estonian people. The monetary equivalent of the coasts in their natural condition as a resource would enable to use it for social cost-benefit analysis of coastal wind parks.

Lake Ülemiste is situated only two kilometres from the centre of Tallinn, but has been closed to public access since Soviet times. Although extensive investments have been made in up-to-date technology for drinking water production, the lake is still closed as a precaution. Practices elsewhere suggest that opening the lake to the public would not threaten drinking water quality. For this reason restrictions imposed on recreation use of Lake Ülemiste imply a potential loss in welfare to the population of Tallinn. Previous research carried out at the Chair of Environmental Economics has shown that the benefits of opening lake Ülemiste to the public would exceed the potential costs of additional water purification equipment. However, the previous estimates were based on data from a survey with a relatively large share of zero responses, which could be an indication of uncertainties. A new survey has been carried out in order to test the robustness of the estimates of the welfare loss from the closure of lake Ülemiste. The aim is to determine how and whether different response formats affect the willingness to pay for the foregone recreation area.

Another theme under research is public environmental expenditures. This theme was reintroduced in 2012 in order to further clarify why public expenditures on environmental protection increased in Estonia during the financial crisis in 2008. Data has been updated and the new data set will help to determine the importance of the increase in availability to additional funding from EU funds for environmental protection on the one hand, and the impact from the green tax reform, which increased public revenues from environmental charges earmarked for environmental purposes, on

the other hand. At the time of carrying out the original research, data were not available for determining the impact from these two sources.

The chair of Environmental Economics continued studies In Business Schools (BS) management. In 2012 the research group of the chair examines the organizational learning rate of BSs worldwide and its dependence on various characteristics of the BSs. The authors measured, using a special instrument (questionnaire) elaborated by them, the learning rate of 105 BSs worldwide. The structure of the measuring instrument is based on Watkins and Marsick's learning organization questionnaire (DLOQ). The questionnaire comprises three levels divided into seven dimensions, which in turn are divided into 45 characteristics. The paper analyses the dependence of the general learning rate of BSs, as well as the dependence of its individual components (levels and dimensions) on the geographical-cultural region of the school location, ownership form and the international accreditations the school has. The most reliable statistically was the dependence on school's ownership form: private capital based BSs are more learning than state or public schools. Less significant is the dependence of learning on geographical-cultural region: BSs in Eastern Europe are slightly more learning than schools in other regions. A significant correlation was missing between the possession of international accreditations and the learning rate. The characteristics that gathered low scores in the questionnaire are addressed separately. Analysis of them enables to identify weaknesses in the organisational learning of BSs, indicating the ways for improving the competitiveness of BSs.
