- uurimisgrupi teadustöö kirjeldus (*inglise keeles*);

The main purpose of the research group "**European Studies and Europeanization**" was to monitor the influence of the international environment onto the political decision-making in Estonia, to draw out potential results of the international developments domestically. There are many promising developments within the socio-economic process in Baltic Sea Region in general and all South-Baltic states (Estonia, Latvia and Lithuania) have meaningful positive economic results today. At the same time the out-migration from the three countries has negative impact to their future developments. In a broad scale these countries have become countries of emigration as according to the most recent census data about 200 thousand people has left the region in last 9 years (in 2004-2012). Total emigration from Central and Eastern European countries to the Nordic countries has been 600 thousand for the same period. This emigration has caused diminishing in labour force that should be either recovered by higher work load for those who have not left or by application of new approaches in facilitating the innovation processes. The main focus should be on the latter as the presence of creativity and innovation has been considered the best grants to ensure economic prosperity. The research group's main focus is on the research aspects on how to measure and assess the reasons of current "brain-drain" in order to estimate possible future emigration. Within the research the proposals will be made on how the harmonization of entrepreneurial and technological innovation processes can be used in order to change the direction of this migration. In order "to bring back necessary workers to Estonia" there should be implemented new measures and

bonuses in regional administration policies, for example, by creating high paid jobs the work environment will be changed to more innovative as well.

- uurimisgrupi teadustöö kirjeldus (*inglise keeles*);

The main purpose of the newly established research group “**Knowledge and Wisdom as the Aim of Scientific Research**“ has been analysis of the essence of scientific research from different angles, often by studying how different branches of science really work. An important motivation for the research group is making sense of the life work of the British philosopher of science Nicholas Maxwell about the need for a revolution in the academia. The core of the revolution has to be the shift from knowledge-inquiry to wisdom-inquiry that would bring really important problems of global significance to the focus of scientific research, instead of the currently prevailing emphasis on knowledge acquisition. There may be a need even for a “New” Enlightenment type of change of attitude to scientific and worldly matters. The work of the members of the research group has enabled to take a deeper look into the main idea from different perspectives: that of traditional philosophy of science, in the context of a new approach called practical realism, experimental philosophy, ethics and cultural studies. The latter has enabled to add a wider perspective to the understanding of wisdom in culture and science. The exemplar branches of science under analysis have varied from physics (the traditional ‘ideal’ science) and chemistry to economics in particular and social science in general. Some members of the group have taken up deeper analysis of the possible understanding of wisdom in culturally diverse circumstances looking beyond the traditions of western science. In a natural way, technology has come into the picture.

In 2013 the members of the group have managed to show that it is reasonable to study the essence of scientific research using the practical approach or even experimental method in philosophical analysis. In addition, the group members have publications showing that a wider cultural look at the main focus of the group is always reasonable and useful.

The membership of the research group consists partly of permanent members of the Chair and partly fluctuates due to temporary contributors from other scientific institutions who join the group for specific task. The research results of the group have regularly been published in a journal-format collection „*Poliitika, Riigiteadus ja Rahvusvahelised Suhted*“ (*Politics, Political Science and International Relations*) of which there are 14 issues so far, covering the period 2001 – 2013. To the most significant research results should be classified the one which subverts the mainstream conception of the diplomatic prelude, and hence the popular understanding of the causes of the WW II. The research was based on the newly discovered documents, which opened up a totally new prospect for understanding not only that period of history but have an effect on the analysis of contemporary international relations as well. Essential were also studies which dealt with different theoretical and empirical problems of politics and international relations, i.e. illuminating the conflicting geopolitical tendencies in Estonian foreign policy at its new birth in 1990s.

- uurimisgrupi teadustöö kirjeldus (*inglise keeles*);

The recent focus of the research team has been laid on further theoretical elaboration of the concept of ways of residing as it appears in different urban residential situations and in the dynamic interplay between social, economic, cultural and spatial structures. The trans-disciplinary research, drawing on an ontological understanding of the duality of agency and structures, which follows the social constructivist epistemological approach, intends to identify altering projective practices and behaviour patterns as related to urban and housing policies and market strategies contributing to the constitution of quality of life on different scales of private, semi-private and public space in the city. With actors' capacity and dispositional strategies forming in different fields of their conduct the primary urban processes under observation are socio-spatial segregation, urban renewal, gentrification, conversion, densification, diversification and symbolic transgression of urban and residential space as they are negotiated between different actor groups and in the context of constructing identities. Conducted in qualitative as well as quantitative perspectives, the recent research involves studies on urban waterfront regeneration, converted former industrial areas into multifunctional spaces with accentuated focus on residential practices, experiential and projective assessment of residential strategies of students and the demand for private and public rental housing, the symbolic meaning of objects in home design of cross-cultural families, the interrelated practice of destination branding and construction of symbolic capital in the context of socio-economic activities in urban heritage space.
