2. Teadus- ja arendustegevuse (edaspidi T&A) iseloomustus

2.1 Struktuuriüksusesse kuuluvad grupid:

a) EU Legal Developments: Head of the Research group is prof Tanel Kerikmäe, members, assoc. prof. Lehte Roots, senior researcher Alexandr Svetlicinii, assoc. prof Tatjana Evas, dr. Archil Chochia, lecturer and Ph.D student Kristi Joamets

The main activities of the group were related to the (now published) preparation and editing of book on EU Charter (Springer Verlag), publishing 1.2. and 3.1 publications in the field. There are several projects related to the Development Aid projects (cooperation with the Ministry of Foreign Affairs) related to Moldavia as neighbourgood country and specific fields of EU law (post-doc project of Alexandr Svetlicinii, supervised by prof. Kerikmäe), also conducting analysis under Jean Monnet project financed by the European Commission. Kristi Joamets is completing her doctoral thesis on Marriage capacity problems in EU legal space. The group is also related to EU-ASEAN research, a contribution to the Cambodian Administrative law textbook was provided and there were several Asian module activities. Some of the activities were related to Latin America, lecture series in EAFIT, Columbia.

D students Addi Rull, Pawan Kumar Dutt, Agnes Kasper etc. There were several projects such as transferring the knowledge on intellectual property for Palestinian judges, also project related to space law. Prof. Nyman Metcalf was elected to be a head of research Council of E-government Academy. The group is preparing the institutional research project together with the institute of informatics (prof. Kuldar Taveter).
