2.1.1 teadustöö kirjeldus (*inglise keeles*);

Jean Monnet Chair of European Law

Main research directions:

- Democratic functioning of the European Union (including dynamics of the relationship between Member State constitutions and EU law);
- Development of the law of the Internal Market of EU;
- Constitutional evolution in Central and Eastern Europe;
- European law on equal treatment and gender equality;
- Human rights in Europe: role of Member States, Council of Europe and European Union;
- European sports law;
- Legal higher education in Europe.

The Chair engaged in several research projects during 2011. One of the most important was drafting the FIDE Estonian Report on EU Charter of Fundamental Rights for the XXV FIDE Congress which takes place in Estonia in 2012. The team was lead by professor Tanel Kerikmäe with co-rapporteurs professor Katrin Nyman-Metcalf, researcher Lehte Roots, lecturer Marianne Meiorg and lecturer Aleksandr Popov.

Another project involved studying the legal implications of higher education in the EU (Tanel Kerikmäe with Lehte Roots). Professor Kerikmäe also conducted research into legitimacy of European integration with professor Katrin Nyman-Metcalf and Ioannis Papageorgiou (Aristotle University of Thessaloniki).

Professor Tanel Kerikmäe contributed with a presentation to the European Conference “Higher Education in the Framework of the 2020 European Union’s Strategy” organized by

The University of Lisbon and its Jean Monnet Center of Excellence Lisbon on 10th and 11th November 2011 and to the conference "European Dilemmas: Internal and External issues facing the EU", organized by European Union Centres Network (EUC) at University of Waikato, New Zealand, 7 - 8 December 2011.

Jaanika Erne joined the Chair as a researcher.

Chair of Law & Technology

Main research directions:

- Telecommunications and media regulation (with focus to developing countries);
- Legal systems of transitional and developing countries (Central and East Asia, Middle East);
- Regulation of technology;
- Developments in Air and Space Law;
- Intellectual property due diligence.

The Chair of Law & Technology developed rapidly. Professor Nyman-Metcalf participated in several international projects as an international experts, while authoring or co-authoring many publications. One of the main activities of the Chair involved setting up a new Master programme in Law & Technology at TUT. This meant cooperation discussions with important international partners as well as complementing the capacity of the Chair. Professor Nyman-Metcalf was in the USA at the beginning of October to discuss possible cooperation in the area of technology law with Stanford University and University of California, Berkeley. She met with the representatives of the "Law, Science and Technology" programme at Stanford University, including professor Hank Greely.

Professor Nyman-Metcalf is involved in a project to develop media regulation in Palestine. She also took part as an expert in the Expert Conference organised by the Folke Bernadotte Academy and ODHIR (the OSCE Office for Democratic Institutions and Human Rights) in Vilnius, 9 to 11 November, on Rule of Law and Administrative Justice, discussing a Handbook for trial monitoring in administrative trials.

Chair of Public Law

Main research directions:

- EU migration law and policy;
- Free movement of third country nationals in the EU;
- Legal situation of asylum seekers;
- asylum, migration and citizenship law and policy of Estonia.

The Chair of Public Law underwent a change in research direction due to professor Madise leaving to Tartu University from 1 September 2011. The new Acting Head of the Chair of Public Law is Dr Lehte Roots, who obtained her PhD recently from the prestigious European University Institute in Florence. The Chair participated in several international research

projects (Estonian report for the ICMPD research on application of the Scientific Visa directive, Comparative analysis of the application of Directive 2003/9/EC regarding reception conditions of migrants with special needs) as well as research conducted by other Chairs.

Human Rights Centre

The main activity of the human rights centre involved in implementing an action funded by the EU's PROGRESS programme in the area of equal treatment. During the action, a study was commissioned on existing research into LGBT issues as well as a thematic conference. Other activities of the project included awareness raising (see www.erinevusrikastab.ee)
